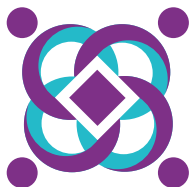

Prize Draw Application

TERMS AND CONDITIONS

- The draw commences in the final quarter of each calendar year and will continue quarterly thereafter until the Board of Directors of Connect Credit Union Limited (hereafter called the Board of Directors) deem otherwise.
- The entrance fee is based on the cost of €13 per quarter (4 quarters €52 per annum). The entrance fee will be deducted from shares in the last month of each quarter and will be deducted in advance of the next Draw or as defined from time to time by the Board of Directors.
- Members must have a Minimum Balance of €30 in their shares prior to the draw deduction to qualify for inclusion in the draw. Failing to do so will result in removal from the Draw with forfeiture of the remaining entrance fee.
- The draw will be non-profit making and any surplus funds will be disposed of by way of extra draws.
- Participation in the draw is limited to eligible members of Connect Credit Union Limited and they must be over 18 years of age on or before the Draw date. Eligible members are living members over and including the age of 18 with an active account.
- Winning members will be notified personally by telephone and by post where these contact details are available.
- Winner names and photographs may be published in the local media and displayed in the Credit Union Offices.
- The draw will be made by a method deemed to be appropriate by the Board. All draws will be held publicly in Connect Credit Union offices at the end of each quarter under the supervision by at least one member of the Board of Directors or Auditors.
- Entry to the Prize Draw is limited to one entry per account. In the case of entries in respect of joint accounts, the joint names will be entered in the draw and if successful, the prize will be awarded in the joint names of the account holders. Where the entrant is a club account the prize will be awarded to the club signatories on behalf of the group.
- Directors, Supervisors, Staff and Volunteers are **NOT** eligible to enter the draw.
- A register of entrants will be maintained at the Credit Union offices.
- Authorisation for inclusion in the draw must be completed prior to participation and no entry is valid unless full fees are paid and credited in advance.
- Financial accounts will be prepared each year to the 30th of September and will be audited by the Auditor appointed by the credit union.
- All eligible members can elect to participate in the draw **ONLY** if written authorisation is received or delivered to the Credit Union.
- In the event that the winner is a person who is in arrears or in default in carrying out any financial commitments/obligation to the credit union, the Board is entitled to withhold delivery of the prize won by the member until the arrears have been paid or the default rectified. Such decision of the Board will be notified in writing to such member and if within seven days of the member being notified, the member fails to comply with the requirements of the Board in relation to such arrears or default, the Board shall be entitled to pay over to the winning member the net proceeds after deducting any such arrears or paying any more monies required to remedy such default.
- If a member does not want to participate in any further Prize Draws, they must give at least one month's notice before the next quarter.
- The decision of the Board of Directors of Connect Credit Union Limited concerning the foregoing rules and changes to same or any matter arising from the quarterly draw will be final and not subject to appeal.
